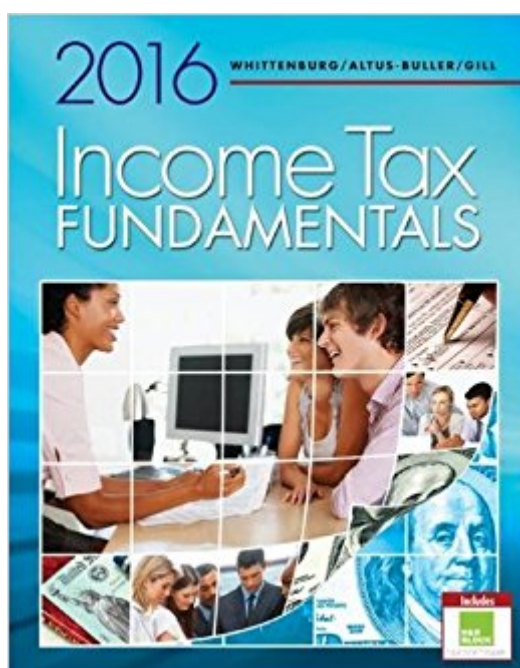

Lamden School of Accountancy at the Fowler College of Business at San Diego

State University. He received a BS in accounting from the University of Florida (Gainesville, FL) and an MS in taxation from Northeastern University (Boston, MA), and a Ph.D. in accounting (University of Massachusetts 2008). Prior to entering academia, Dr. Gill worked twelve years in the field of accounting, including roles in public accounting, internal audit, corporate accounting, and, ultimately, vice president of finance. She attended Reed College in Portland, Oregon for two years, holds a B.A. in Mathematics from the University of California at San Diego and a M.S. in Accounting from San Diego State University. Her practical experience includes work as a tax manager for Arthur Young, now Ernst & Young, one of the Big 8 accounting firms at the time.
