

This book didn't blow me away, but it was still pretty entertaining.

When I was a kid, my father used to subscribe to Discover magazine, and I loved to read Perri Klass's column, Vital Signs. She described medicine so vividly that I started to imagine what it would be like to be a doctor myself. Now I am one, and I love to read and re-read her words, they are like comfort food. She is hilarious wise, realistic and insightful, sometimes all in one paragraph."I still remember, for example, the first patient who ever took a really strong dislike to me. I was a medical student and he was a grouchy older gentleman who wasn't particularly pleased to have me walk in and introduce myself. He quizzed me for a few minutes to see whether I was properly acquainted with the sixteen-year saga of his ailments, decided I was insufficiently prepared to care for him, announced that he didn't want "any more goddamn interfering lady doctors," and ordered me to get lost. When I left the room, I was crushed. It had never occurred to me that I would be rejected by a patient."I recommend her to my students, I send her books as gifts to my doctor friends.
