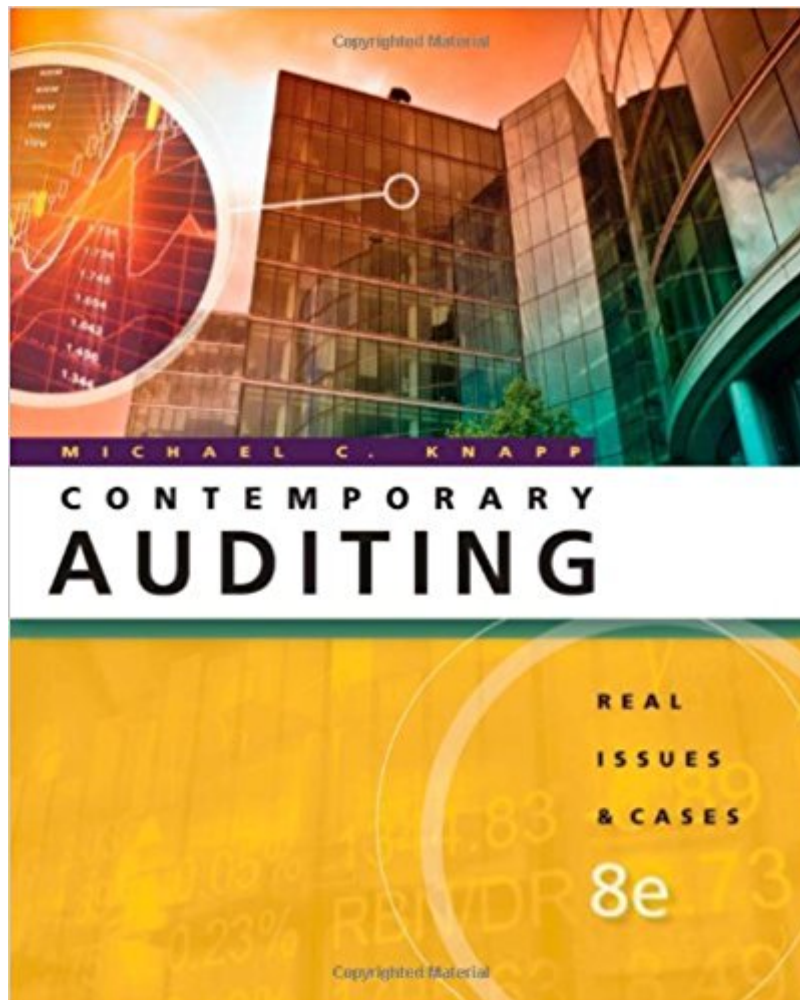

The questions at the end of each case sometimes go beyond what you might find in an auditing text, so they challenge the student to not just regurgitate what we have read in the other text last semester.
