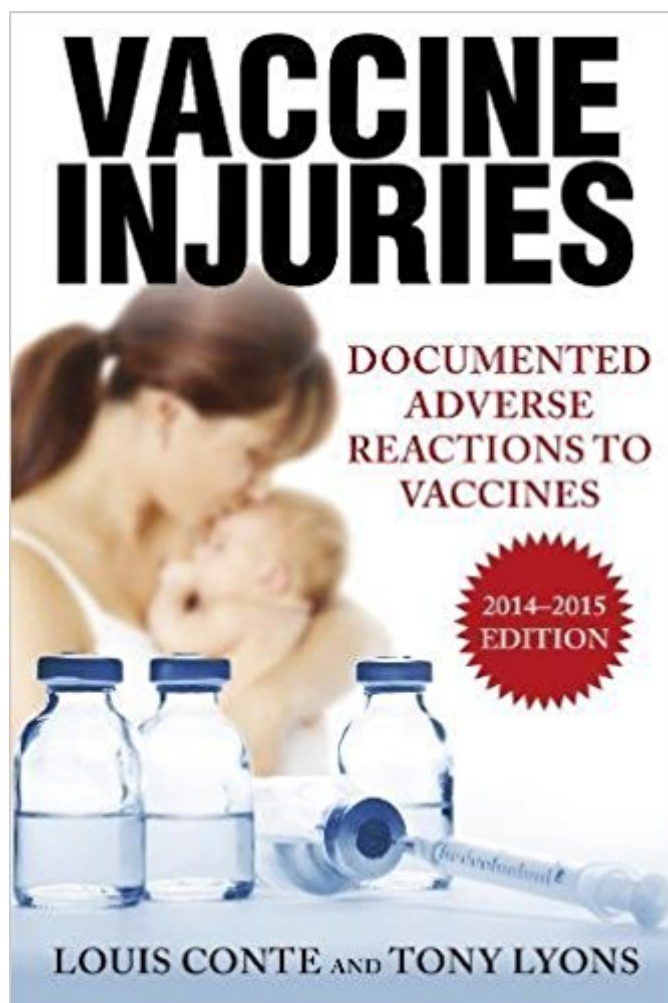

# Vaccine Injuries: Documented Adverse Reactions To Vaccines



## Synopsis

Reveals the truth behind the controversial issue of vaccine-related injuries. Proponents declare that vaccines have saved millions of lives. Critics claim that the success is overstated and that vaccines may even be dangerous. Many consider mandatory vaccinations a violation of individual rights or religious principles. Many in public health argue that vaccine mandates are critical and justified and that antivaccination sentiment has resulted in outbreaks of preventable childhood illnesses. Vaccine critics point to mainstream medicine's denial of and underreporting of vaccine injury. Vaccine injuries have happened in the past and continue to happen today, and neither the mainstream medical establishment nor the government has ever fully and transparently addressed the issue of vaccine injury. In the 1980s, the United States addressed individual cases of vaccine injury by establishing the NVICP—the National Vaccine Injury Compensation Program—a controversial Department of Health and Human Services program. The NVICP was intended to be “non-adversarial, compassionate, and generous” to vaccine-injury victims. However, many vaccine-injury victims and safety advocates believe that the program is not functioning as intended. There are also concerns that the program is keeping the reality of vaccine injury from public inspection. *Vaccine Injuries*, a groundbreaking book in the field, reveals cases of vaccine injury from the NVICP—something that has never been offered to the public—and lets readers assess vaccine injuries for themselves.

This book is a long-awaited analysis that hopefully will promote the study, treatment and prevention of vaccine injuries -- which have been unnecessarily blocked by fear. For vaccine consumers hesitant to intellectually grasp this topic, first re-read this book's subtitle: "Documented Adverse Reactions to Vaccines." Start by reading physician reports to the Vaccine Adverse Events Reporting System (VAERS), a database of the U.S. Department of Health and Human Services. Move on to cases filed, conceded or settled in the National Vaccine Injury Compensation Program (NVICP). Then move on to studies of the Vaccine Safety Datalink (VSD), a "collaborative project between CDC's Immunization Safety Office and nine health care organizations." Once you've come to realize that vaccine injury has existed for many decades, begin asking whether the organizations assigned to study vaccine injury are actually performing their mission without bias or concealment. Look into the global Brighton Collaboration, which sets recognized definitions of vaccine injury. Does that group seem willing to relegate adverse reactions to the dustbins of mystery? Will admissions of vaccine statistical fraud by CDC senior scientist Dr. William Thompson ever be reported by corporate media, or remain limited to YouTube videos or a press release from the Morgan Verkamp whistleblower law firm? Case in point: The late director Mike Nichols suffered a vaccine reaction at age four, losing all his hair to the autoimmune disorder alopecia. Vaccine injury is a spectrum disorder, lacking any useful study for determining vulnerable population subsets to design humane medical treatments and prevent further brain and neuroimmune damage. Vaccines are an ongoing experiment, and irrational deification and fear are blocking honest scientific progress in reducing vaccine adverse reactions. It is incumbent upon each reader to recognize their primal fear of disease and treat it properly -- with healthy doses of logic and compassion for those people physically unable to tolerate vaccines.

Reading Vaccine Injuries: Documented Adverse Reactions to Vaccines should be a required part of the informed consent process prior to any parent allowing their child to be vaccinated, prior to any adult allowing a vaccine for themselves, and prior to any vaccine legislation being initiated or passed. Louis Conte and Tony Lyons have done a brilliant job of concisely summarizing the problematic, yet unethically covered-up, history of vaccination, going back to its inception some 200 years ago. In the opening chapters, my recurrent thought was, "The more things change, the more they stay the same." In other words, from the get-go, mothers reported catastrophic injuries and illnesses in their previously-healthy children post-vaccination, not to mention deaths. Yet "experts" declared that mothers' accounts were not reliable, and should therefore be dismissed. Tragically,

the same arrogance of the "experts" continues today. This book exposes many dark truths which the American public needs to hear, and quickly. Vaccine injuries are real. There is no reliable evidence to support the claim that they are rare. Vaccine injuries are dismissed, denied, and hidden by the very people who are charged with acknowledging them, treating them, reporting them, investigating them, and compensating them. Parents of vaccine-injured children, and vaccine-injured adults, are most often left to fend for themselves, and are treated with disdain and hostility. What other group of injured people is treated this way? Don't miss reading the section on Reported and Unreported Cases of Vaccine Injuries from 2013. If reading those tragic stories of vaccine injuries and deaths don't give a parent considering vaccinating their child pause, then nothing will. However, I am quite certain that it will, in a most powerful way. This book has the potential to save lives, open eyes, and most importantly, change policy. Of course, for it to be effective, people must read it. I suggest buying at least 2 copies, one for yourself, and one for a friend, relative, doctor, legislator, or local library. Knowledge is power, and this book will increase the knowledge of anyone who reads it, enabling and empowering them to make better, safer, and healthier choices for themselves and their children.

Well researched, informative, and not to miss. This book reviews a small sample of recent legal cases which include very detailed medical data and studies supporting the victim's cases. The author begins the book by reviewing the history of vaccine development as well as the legal process in which a vaccine must go through to be added to the required schedule. He brings up multiple valid points in regards to who is making our laws and how they are financially related to those that benefit from the use of their vaccines. The author then reviews 6-7 legal cases in total detail in which the victim was found to have, more likely than not, suffered from a serious adverse reaction to a vaccine. He ends with reviewing cases that were mutually agreed upon, through a mediator or other non-full trial method, and found for the victim. I believe it would be impossible to read this book and not walk away with some amount of doubt in regards to the safety of vaccines. Forcing a toxin into a person's body when that toxin has very well documented adverse effects is criminal, regardless of the likelihood of an adverse reaction.
